Technology Acceptable Use Student Policy

Student Use of Technology

- 1. I will follow the directions of the adult in charge of the technology facility.
- 2. I will report any technical problems immediately to the teacher or the adult in charge.
- 3. I will not use the network in such a way that will disrupt the use of the network by others.
- 4. I understand that vandalism will result in cancellation of my privileges. Vandalism is any attempt to harm or destroy another person's data or the school's software or hardware.
- 5. I will avoid physical aggression towards the technology.
- 6. I will not bring, use, or install any personal software.
- 7. I will not have food or drinks near the computers.
- 8. I will keep my computer work area clean.
- 9. I will use technology for educational reasons only.

Digital Citizenship

- 1. I will seek permission before going online or downloading any materials from the internet.
- 2. I will appropriately cite any materials used from the internet.
- 3. I will not read personal e-mail messages or engage in social media sessions of any kind.
- 4. I will be positive, courteous and respectful in my digital messages to others and not post comments or information that is offensive to the school, faculty, other students, or the parish.
- 5. I will use positive language and refrain from language that is considered offensive or threatening to persons of a particular race, gender, religion, sexual orientation or disability. I will treat others as I want to be treated.
- 6. I will not forward/share inappropriate materials or communications and report harassment/abuse.
- 7. I will protect my identity by seeking parental permission before
 - a. signing up for any online services
 - b. giving out personal or identifiable information, or those of others
 - c. sending my picture to anyone
 - d. agreeing to meet people I encounter online
 - e. ordering anything online or giving out credit-card information
